#### 1. Introduction

At Rugby Free Secondary School, we are committed to promoting positive mental health and emotional wellbeing to all students, their families and members of staff and governors. Our open culture allows students' voices to be heard, and through the use of effective policies and procedures we ensure a safe and supportive environment for all affected - both directly and indirectly - by mental health issues including mental illness.

# 2. Scope of Policy

This policy is a guide to all staff – including non-teaching, governors and volunteers – outlining Rugby Free Secondary School's approach to promoting good mental health and emotional wellbeing.

It should be read in conjunction with other relevant school policies.

# 3. Policy Aims

- Promote positive mental health and emotional wellbeing in all students and staff
- Increase understanding and awareness of common mental health issues
- Enable staff to identify and respond to early warning signs of mental ill health in students
- Enable staff to understand how and when to access support when working with young people with mental health issues
- Provide the right support to students with mental health issues and know where to signpost them and their parents/carers for specific support
- Develop resilience amongst students and raise awareness of resilience building techniques
- Raise awareness amongst staff and gain recognition from SLT that staff may have mental health issues, and that they are supported in relation to looking after their wellbeing; instilling a culture of staff and student welfare where everyone is aware of signs and symptoms with effective signposting underpinned by behaviour and welfare around school.

# 4. Key Staff Members

This policy aims to ensure all staff take responsibility to promote the mental health of students, however key members of staff have specific roles to play:

- Pastoral Staff
- Designated Safeguarding Lead
- Senior Mental Health Lead





- SENCO
- PSHE Coordinator

If a member of staff is concerned about the mental health or wellbeing of student, in the first instance they should speak to the Head of Year and report this on CPOMS.

If there is a concern that the student is high risk or in danger of immediate harm, the school's child protection procedures should be followed and the student should remain under supervision while the staff member seeks immediate support.

If the child presents a high-risk medical emergency, relevant procedures should be followed, including involving the emergency services if necessary.

# 5. Individual Safety Plans/ Risk Assessment

When a student has been identified as having cause for concern, such as risk of self-harm, truanting and missing episodes, it is recommended that an Individual safety plan or Risk Assessment should be completed. The development of the plan should involve the student, parents/carers, and relevant professionals.

Suggested elements of this plan include:

- Details of the student's situation/condition/diagnosis
- Special requirements or strategies, and necessary precautions
- Medication and any side effects
- Who to contact in an emergency
- The role the school and specific staff

#### 6. Teaching about mental health

The skills, knowledge and understanding our students need to keep themselves - and others - physically and mentally healthy and safe are included as part of our PSHEE curriculum, assemblies, tutor time and specialist drop down days. We will follow the guidance issued by the PSHEE Association to prepare us to teach about mental health and emotional health safely and sensitively.

Incorporating this into our curriculum at all stages is a good opportunity to promote students' wellbeing through the development of healthy coping strategies and an understanding of students' own emotions as well as those of other people.

Additionally, we will use such lessons as a vehicle for providing students who do develop difficulties with strategies to keep themselves healthy and safe, as well as supporting students





to support any of their friends who are facing challenges. **See Section 14 for Supporting Peers.** 

## 7. Signposting

We will ensure that staff, students and parents/carers are aware of the support and services available to them, and how they can access these services. Support follows a Waved Approach, including Wave 1 – Universal, Wave 2 – In-house support and Wave 3 – External Agencies (pastoral staff can refer through the Intervention Panel).

Within the school (noticeboards, common rooms, toilets etc.) and through our communication channels (websites, Blogs, Class Charts, Bromcom, The Student Voice and social media), we will share and display relevant information about local and national support services and events.

The aim of this is to ensure students understand:

- What help is available
- Who it is aimed at
- How to access it
- Why should they access it
- What is likely to happen next

#### 8. Sources or support at school and in the local Community

#### **School Based Support:**

- Mental Health and Wellbeing Strategy including a 3-wave intervention package
- The Student Voice for students to log concerns
- Website support links for students accessible through Student Voice
- Weblinks for students and parents/carers are shared through the weekly 'Mental Health Top Tips' on social media
- Referrals to external support provisions including the RISE team
- Large Pastoral Team
- Inclusion Team
- Peer Mentoring Programme
- These interventions and supports are accessible for students through from Year 7 to Year 13
- Wave 1 3 interventions are monitored through the 'plan, do, review' process
- All staff have regular assemblies, weekly student briefings and PSHEE to make them aware of support and school offers.





This is likely to include information about pastoral staff including behaviour and learning support and school counsellors.

Interventions include a variety of 1:1 and small group work with our internal Intervention Lead and we also receive external support from agencies such as On Track, Rugby Youth for Christ, S.A.L.T, Young Black Men, Connect 4 Health and the School Nursing Team

#### **Local Support**

In Rugby, there are a range of organisations and groups offering support, including the **RISE Partnership**, a group of providers specialising in children and young people's mental health wellbeing. These partners deliver accessible support to children, young people and their families, whilst working with professionals to reduce the range of mental health issues through prevention, intervention, training and participation.

#### 9. Warning Signs

Staff may become aware of warning signs which indicate a student is experiencing mental health or emotional wellbeing issues. These warning signs should always be taken seriously and staff observing any of these warning signs should alert the Designated Safeguarding Lead who will then discuss this with the Senior Mental Health Lead to seek the most appropriate support.

Possible warning signs, which all staff should be aware of include:

- Physical signs of harm that are repeated or appear non-accidental
- Changes in eating / sleeping habits
- Increased isolation from friends or family, becoming socially withdrawn
- Changes in activity and mood
- Lowering of academic achievement
- Talking or joking about self-harm or suicide
- Abusing drugs or alcohol
- Expressing feelings of failure, uselessness or loss of hope
- Changes in clothing e.g. long sleeves in warm weather
- Secretive behaviour
- Skipping PE or getting changed secretively
- Lateness to, or absence from school
- Repeated physical pain or nausea with no evident cause
- An increase in lateness or absenteeism





# **10.**Targeted Support

We recognise some children and young people are at greater risk of experiencing poorer mental health. For example, those who are in care, young carers, those who have had previous access to CAMHS, those living with parents/carers with a mental illness and those living in households experiencing domestic violence.

We work closely with external agencies including school nurses and RISE to support the emotional and mental health needs of school-aged children and are equipped to work at community, family and individual levels. Their skills cover identifying issues early, determining potential risks and providing early intervention to prevent issues escalating.

We ensure timely and effective identification of students who would benefit from targeted support and ensure appropriate referral to support services by:

- Providing specific help for those children most at risk (or already showing signs) of social, emotional, and behavioural problems
- Working closely with Families First, Rugby Children's Services, Coventry and Warwickshire RISE and other agencies services to follow various protocols including assessment and referral
- Identifying and assessing in line with the Early Support children who are showing early signs of anxiety, emotional distress, or behavioural problems
- Discussing options for tackling these problems with the child and their parents/carers
- Agree an Individual Safety Plan/Risk Assessment (if needed)
- Providing a range of interventions that have been proven to be effective according to the child's needs
- Ensure young people have access to pastoral care and support, as well as specialist services, including Coventry and Warwickshire RISE, so that emotional, social and behavioural problems can be dealt with as soon as they occur
- Provide young people with clear and consistent information about the opportunities
- available for them to discuss personal issues and emotional concerns. Any support offered should take account of local community and education policies and protocols regarding confidentiality
- Provide young people with opportunities to build relationships, particularly those who
  may find it difficult to seek support when they need it
- The identification, assessment, and support of young carers under the statutory duties outlined in the Children & Families Act 2014.

# 11. Managing Disclosures





If a student chooses to disclose concerns about themselves, or a friend, to any member of staff, the response will be calm, supportive and non-judgemental.

All disclosures should be reported immediately to the safeguarding team and recorded factually and confidentially on CPOMs with information before the end of the school day, including:

- Date
- Name of member of staff to whom the disclosure was made
- Nature of the disclosure & main points from the conversation
- Agreed next steps

This information will be shared with Safeguarding Leads and Heads of Year.

## 12.Confidentiality

If a member of staff feels it is necessary to pass on concerns about a student to either someone within or outside of the school, then this will be first discussed with the student. We will tell them:

- Who we are going to tell
- What we are going to tell them
- Why we need to tell them
- When we're going to tell them

Ideally, consent should be gained from the student first, however, there may be instances when information must be shared, such as students up to the age of 16 who are in danger of harm.

It is important to also safeguard staff emotional wellbeing. By sharing disclosures with a colleague this ensures one single member of staff isn't solely responsible for the student. This also ensures continuity of care should staff absence occur and provides opportunities for ideas and support.

In most instances' Parents/carers must will always be informed, but students may choose to tell their parents themselves. If this is the case, a timescale of 24 hours is recommended to share this information before the school makes contact with the parents/carers. This would not be followed if there was a risk of significant harm to themselves or someone else.

If a student gives us reason to believe that they are at risk, or there are child protection issues, parents/carers should not be informed, but the child protection procedures should be followed.

## 13. Whole School Approach

#### Working with parents/carers

If it is deemed appropriate to inform parents/carers, there are questions to consider first:





- Can we meet with the parents/carers face-to-face?
- Where should the meeting take place some parents are uncomfortable in school premises so consider a neutral venue if appropriate.
- Who should be present students, staff, parents etc.?
- What are the aims of the meeting and expected outcomes?

We are mindful that for a parent, hearing about their child's issues can be upsetting and distressing. They may therefore respond in various ways which we should be prepared for and allow time for the parent to reflect and come to terms with the situation.

Signposting parents/carers to other sources of information and support, such as the Family Information Service, can be helpful in these instances. At the end of the meeting, lines of communication should be kept open should the parents/carers have further questions or concerns. Booking a follow-up meeting or phone call might be beneficial at this stage.

Ensure a record of the meeting and points discussed/agreed are added to the student's record and on CPOMS where appropriate.

#### Supporting parents/carers

We recognise the family plays a key role in influencing children and young people's emotional health and wellbeing; we will work in partnership with parents and carers to promote emotional health and wellbeing by:

- Ensuring all parents/carers are aware of and have access to promoting social and emotional wellbeing and preventing mental ill\_health problems
- Highlighting sources of information and support about common mental health issues through our communication channels (website, newsletters etc.)
- Offering support to help parents/carers develop their parenting skills. This may involve
  providing information or offering small, group-based programmes run by community
  nurses (such as school nurses and health visitors) or other appropriately trained health
  or education practitioners.
- Ensuring parents carers and other family members living in disadvantaged circumstances are given the support they need to participate fully in activities to promote social and emotional wellbeing. This will include support to participate in any parenting sessions, by offering a range of times for the sessions or providing help with transport and childcare. We recognise this might involve liaison with family support agencies.

## **14.Supporting Peers**

When a student is suffering from mental health issues, it can be a difficult time for their friends who may want to support but do not know how to. To keep peers safe, we will consider on a case-by-case basis which friends may need additional support. Support will be provided in one to one or group settings and will be guided by conversations by the student who is suffering and their parents with whom we will discuss:





- What it is helpful for friends to know and what they should not be told
- How friends can best support
- Things friends should avoid doing / saying which may inadvertently cause upset
- Warning signs that their friend needs help (e.g. signs of relapse)

Additionally, we will want to highlight with peers:

- Where and how to access support for themselves
- Safe sources of further information about their friend's condition
- Healthy ways of coping with the difficult emotions they may be feeling

## 15.Training

As a minimum, all staff will receive regular training about recognising and responding to mental health issues as part of their regular child protection training to enable them to keep students safe. A nominated member of staff will receive professional Mental Health First Aid training or equivalent and hold the role of Senior Mental Health Lead.

We will host relevant information on our website for staff who wish to learn more about mental health. The MindEd learning portal provides free online training suitable for staff wishing to know more about a specific issue.

Training opportunities for staff who require more in-depth knowledge will be considered as part of our performance management process and additional CPD will be supported throughout the year where it becomes appropriate due developing situations with one or more students.

Where the need to do so becomes evident, we will host twilight training sessions for all staff to promote learning or understanding about specific issues related to mental ill health.

Suggestions for individual, group or whole school CPD should be discussed with the Deputy Headteachers who can also highlight sources of relevant training and support for individuals as needed.

## **16.Policy Review**

This policy will be reviewed every two years as a minimum. The next review date is March 2026

In between updates, the policy will be updated when necessary to reflect local and national changes. This is the responsibility of the DSL.

Any personnel changes will be implemented immediately.
